



What are cookies?

A cookie is a file that is downloaded to your computer when you access certain websites. Cookies allow a website, among other things, to store and retrieve information about browsing habits of a user or their computer and, depending on the information they contain and the way you use your computer, they can be used to recognise the anonymous user.

Cookies are only associated with an anonymous User and his or her computer and do not provide references that allow the User's personal data to be deduced.

In the case of registered Users who register or who have logged in, they may benefit from more personalised services oriented to their profile, thanks to the combination of the data stored in the cookies with the personal data used at the time of their registration. These Users expressly authorise the use of this information for the aforementioned purpose, without prejudice to their right to refuse or disable the use of cookies.

Types, purpose and operation of cookies in general.

- Types of cookies according to the length of time they remain activated.

Depending on the length of time that they remain activated in the terminal equipment, we can distinguish:

Session Cookies: These are a type of cookie designed to collect and store data while the user accesses a website.

They are usually used to store information that only needs to be kept for the provision of the service requested by the user on a single occasion (e.g. a list of products purchased).

Persistent cookies: These are a type of cookie in which the data remains stored in the terminal and can be accessed and processed for a period defined by the party responsible for the cookie, which can range from a few minutes to several years.

- Types of cookies depending on the entity that manages them.

Depending on the entity that manages the equipment or domain from which the cookies are sent and processes the data obtained, we can distinguish:



First-party cookies: These are those that are sent to the user's terminal equipment from a computer or domain managed by the editor itself and from which the service requested by the user is provided.

Third-party cookies: These are those that are sent to the user's terminal equipment from a computer or domain that is not managed by the editor, but by another entity that processes the data obtained through the cookies.

- Types of cookies according to their purpose.

Depending on the purpose for which the data obtained through cookies are processed, we can distinguish between:

- **Technical Cookies:** These are those that allow the user to browse through a website, platform or application and use the different options or services that exist on it, for example, control traffic and data communication, identify the session, access restricted access parts, remember the elements that make up an order, make the purchase process of an order, make the application for registration or participation in an event, use security features while browsing, store content for broadcasting videos or sound or share content through social networks.

- **Personalisation cookies:** These cookies allow the user to access the service with certain predefined general characteristics depending on a series of criteria in the user's terminal, such as the language, the type of browser used to access the service, the regional configuration from which the service is accessed, etc.

- **Analysis cookies:** These cookies allow the party responsible for them to monitor and analyse the behaviour of the users of the websites to which they are linked. The information collected through this type of cookies is used to measure the activity of the websites, application or platform and for the elaboration of browsing profiles of the users of these sites, applications and platforms, in order to introduce improvements based on the analysis of the data on the use made by the users of the service.

- **Advertising Cookies:** These are those that allow the management, in the most effective way possible, of the advertising spaces that, where appropriate, the editor has included on a website, application or platform from which the requested service is provided based on criteria such as the edited content or the frequency at which the advertisements are shown.

- **Behavioural advertising cookies:** These cookies allow the management, in the most effective way possible, of the advertising spaces that, where appropriate, the editor has included on a website, application or platform from which the requested service is provided. These cookies store information on the



behaviour of users obtained through the continuous observation of their browsing habits, which allows a specific profile to be developed in order to display advertising based on the same.

- Consent and Authorisation for the use of cookies

When you access this website for the first time, you will see a space or banner informing you of the use of cookies and where you can consult this cookie policy by clicking on a link. If you consent to the use of cookies, continue browsing using the scroll bar or click on a link (accept) as appropriate, it will be understood that you have consented to our cookies policy and, therefore, acceptance for the installation of cookies on your computer or device, except to the extent that you have modified the configuration of your browser to reject the use of cookies.

- What types of cookies does this particular website use? Definition, identification and purpose of the cookies on this website that are not exempted by the LSSI.

They would be:

- Analysis cookies: These are cookies that are either processed by us or by third parties and allow us to quantify the number of users and thus carry out the measurement and statistical analysis of the use made by users of the service offered. To do this, your browsing on our website is analysed in order to improve the range of products or services that we offer.

- Advertising Cookies: These are those that, either processed by us or by third parties, allow us to manage as effectively as possible the supply of advertising spaces on the website, adapting the content of the advertisement to the content of the service requested or to the use you make of our website. To do this, we can analyse your Internet browsing habits and we can show you advertising related to your browsing profile (check whether or not they are those listed below, as well as the purpose of them).
